



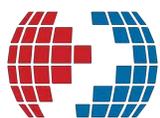
SecureWatch for Supplier Audits



Performing regular audits on your suppliers is essential since their business practices directly impact your own. Supplier audits document the relationship between different companies and verify a supplier's compliance with required processes and regulations. This ensures you know the status of your product from when its components are gathered to when it's shipped and arrives at your business.

Supplier audits are an effective method of identifying, eliminating and preventing problems in a supplier's processes, management, or products. You can also ensure you reduce costs from violations by preventing them. For example, the entry of goods by means of false statements (18 U.S.C. § 1542) is punishable by the recovery of duty loss plus a fine of \$5000 per count, imprisonment up to 2 years, or both. The cost of ensuring you and your supplier are compliant is marginal to the fees you could quickly accrue. It is also possible to have certain certifications suspended, such as the C-TPAT, that many customers require to do business.

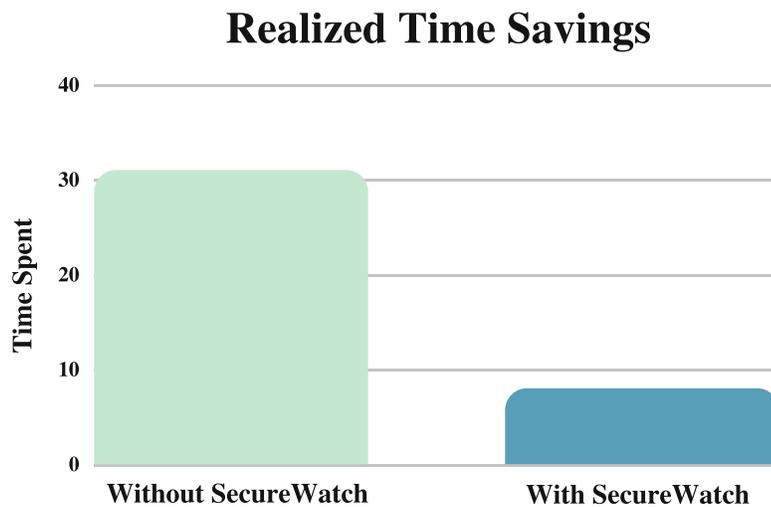
1. The supplier's ability to meet your designated requirements
2. The quality of your end product after using the supplier's product or service
3. Nonfulfillment of purchasing requirements

While audit lists can be altered to include any area you deem necessary, keep in mind that SecureWatch has an extensive content library, containing over 35 state and federal regulations, relevant industry standards, guidelines and best practices; documents include C-TPAT, AEO, ISO 27001 and many others.

While preparing your survey, simply select any content library you would like to ensure you are compliant with. Users can select question categories or individual questions to exclude from their survey when referencing an entire regulation or industry standard. Responses can also be customized and can include up to 20 different options for a single question. SecureWatch can be set to automatically remind users to complete assessments and notify admins of their completion. The software also recommends action plans, assigns tasks and tracks and manages remediation based on the results of a survey.

Integrated with crime data resources such as Cap Index, Security Gauge, and Global Incident Map to identify the risk of a location, the user can determine if a supplier is a higher risk due to their location. Select a pre-built template from a content library with thousands of available questions. Create and distribute custom surveys based on your organization's unique supplier requirements criteria.

SecureWatch simplifies the documentation process by allowing the supplier to type notes directly into our platform. Using our app, the supplier can complete their assessment from any mobile device, answering assessment questions in real time as they walk through their facility.

Photos can be taken and uploaded directly into the assessment file. Upon completion of your supplier audit, you'll want to document the results using your detailed notes and referencing any relevant objective evidence.
